

Digital Forensics Scholarship for Women in Law Enforcement

About the Scholarship

Since earning her Certified Forensic Computer Examiner (CFCE) credential in 2014, Edith's career in digital forensics has reached inspiring heights. With 18 years of law enforcement experience, she later transitioned to the private sector, earning multiple accolades for her achievements.

Grateful for her journey, Edith is giving back to the IACIS community by sponsoring the Digital Forensics Scholarship for Women in Law Enforcement.

Scholarship Benefits

The scholarship, funded by Edith Santos, covers the registration fee for the IACIS BCFE training in Orlando, Florida.

Eligibility

Applicants must be female, working in a law enforcement agency (sworn or civilian capacity).

Application Requirements

Applications must include the following, submitted together as a single PDF using the filename format of *Surname_First Name.pdf*:

- 1. Completed Application Form
- 2. Signed Privacy Statement
- 3. Curriculum Vitae (CV)
- 4. Essay (maximum 500 words) describing career goals and how BCFE training will be beneficial
- 5. Proof of registration for the 2026 BCFE Orlando course
 - When registering, applicants may select the "Pay with Invoice/Purchase Order" option. This allows registration without upfront payment. If the applicant is not awarded the scholarship and cannot attend through agency funding, she must notify IACIS to withdraw her registration so the seat can be offered to someone on the waiting list.
- 6. Supervisor letter on agency letterhead confirming:
 - Employment with a law enforcement agency
 - o Approval to be considered for the scholarship
 - o Confirmation that BCFE training will benefit current or future duties
 - Agreement that any costs not covered by the scholarship will be assumed by the agency and/or applicant

Timeline

- Applications accepted: October 1 November 30, 2025
- Selection made: No later than December 30, 2025
- Notification: All applicants will be informed of their status via email once a selection is made
- Public announcement: January 2026 via IACIS ListServ and IACIS social media (Facebook, LinkedIn, X, and Instagram)
