Only classes where attendance is documented and certificates issued will be accepted. No webinars or other undocumented training can be submitted. Certificants must provide copies of completed courses, training certificates, or other documentation to the Recertification Subcommittee when the application for recertification is submitted.

Applicants who teach related topics in computer/digital forensics, information technology, or investigations may apply formal classroom hours to this requirement. The Certification Committee reserves the right to verify training documented by an applicant.

You will not be allowed entry into the Certification Exercise until your documents have been uploaded and approved by our Certification Admin.

IACIS strongly recommends JPG (or similar image types) files combined into one zip file for upload. Total upload size should not exceed 7MB. The uploaded certificates need to be legible, however can be reduced in size to aid in submission.
